This Tentative Agreement between the Coast Community College District and the Coast Federation of Classified Professionals, Local 4794 (hereinafter referred to as the “Federation”) is expressly made pursuant to the Educational Employment Relations Act and the Collective Bargaining Agreement (“Agreement”) between the parties.

All language currently in effect in the Agreement is intended to remain unchanged except as agreed below.

**ARTICLE 28. AGREEMENT CONDITIONS, DURATION, AND RE-OPENERS**  
**Section 28.3 Only**

**28.3.a Duration.** This Agreement shall become effective upon the execution by both parties, except as otherwise specified, and shall continue up to and including June 30, 2027.

**28.3.b. 2025-2026 Re-openers.** The parties agree that for 2025-2026, either party may reopen any two Articles of their choice, plus any other mutually agreed upon Articles.

**28.3.c. 2026-2027 Re-openers.** The parties agree that for 2026-2027, either party may reopen any two Articles of their choice, plus any other mutually agreed upon Articles.
